

Update on the Sycamore Store

It has been two years since I interviewed architect Dean Brenneman, the new owner of the Sycamore Store, about his plans to have that little wooden structure designated worthy of historic preservation and move his professional offices there. But the weather-beaten zoning notices are still in the front yard, so this week I made some phone calls to find out why it's taking so long.

Before buying the property, Brenneman completed several months of feasibility study and found the County and all the neighbors but one excited about his plans. But his research had no way of revealing the extremes to which that opposing voice was willing to go to block his preservation efforts, including hiring a lawyer and turning the hearings into a long, drawn-out, expensive and difficult process. Despite this, Brenneman sounds amazingly upbeat. "The Hearing Commissioner will render a decision late this summer," he said. "It's looking promising and we're hopeful."

At this point he has succeeded in securing Historic Designation for the store and a Zoning Text Amendment that allows his firm Brenneman & Pagenstecher to apply for use of the property as professional offices. The final step is approval of a Special Exception to allow their use and occu-

pancy of the Store. The actual hearings and testimony in this final process have been completed, and now everyone awaits the Hearing Examiner's decision.


I spoke with two of our Club members who were among those testifying at the County hearings in favor of preservation. Phil Thorson moved to his home on MacArthur Boulevard in 1947 and used to buy all his groceries at the Sycamore Store. He loves the idea of preserving this "quaint reminder of earlier days," and sounds excited about the grocery counter that will remain in the reception area and the restoration of the lighted sign. In addition, he was motivated to testify because Brenneman's plan will prevent the obvious alternative: "Someone else coming in and building as big and as high a McMansion as they can."

Harry Schwartz testified because he felt that it would be "a travesty to lose this landmark building that sits on the corner and lets you know you've arrived at Glen Echo Heights." Schwartz, the former director of public policy at the National Trust for Historic Preservation, also felt that his professional background gave him added perspective that might be useful in the hearings. In his experience it is rare for someone to be willing to rehab a property with historic value for a new use consistent with its original use. This situation was unique because usually when people want to preserve a building, no one comes forward with an economically viable proposal. The property was on the market for months. "I was amazed when Brenneman came along and was willing to preserve the store," he said. "We should be giving him a gold medal because he's the only person who stepped up and said 'I'm willing to save this landmark'."

Sycamore Island Regatta


Monday, September 4, 2006, 1:30 PM till dark

James Super

Top Male Kayak Paddler at 2006 Collegiate National Championships

James Super of Arlington, Virginia, was recently named top male kayak paddler at the 2006 Collegiate National Championships for Sprint Canoe and Kayak, held at the Olympic Training Center in Chula Vista, California, May 12-14, 2006. James, 19, racing for the Stanford University canoe and kayak team, finished first in all the men's one-person sprint kayak events at 200-, 500-, and 1,000-meter distances. The canoe and kayak team, coached by Gina Sanchez, is a club sport at Stanford, and Super has been named team captain for the next school year. The team placed second overall in the championships after Georgia Tech. Super, currently a freshman at Stanford, graduated in 2005 from Wakefield High School in Arlington.

James is the son of Sue and Greg Super, who have been members of Sycamore Island since the 1970s. Readers may remember Islander stories in years past about some of James's memorable birthday parties and treasure hunts on the Island. James is also a member of the Washington Canoe Club (WCC), Washington, DC, located on the Potomac River near Key Bridge in Georgetown. He has raced competitively since 1997 for the WCC kayak team, currently coached by former Olympic sprint kayak coach, Jerzy Dziadkowiec. At the 2005 USA Canoe and Kayak National Sprint Championships held in Seattle, Washington last year, James raced with Geoff Calhoun, Andrew Soles, and Tom Dziadkowiec in the 4-person kayak that won the senior men's 1,000meter race to capture the Eric Feicht Memorial Trophy for WCC. He will compete again for WCC at the 2006 National Sprint Championships to be held in Gainesville, Georgia July 24-29 at Lake Lanier (venue for the 1996 Olympic flatwater events).

In Touch With Joe....

Thursday -- June 1, 2006

The swimming season is now in full swing and everyone is coming down to the river to cool off. I finally jumped in for the first time on Saturday; usually I'm in by late April but this year it was too cold. I had twenty five-yearolds here on Tuesday and yesterday there was a party of ten that came down for a picnic. The fishermen are also out now that the water is warm and the fish are active again.

Monday -- June 5, 2006

I finally spent the night on Ruppert's Island. I took two thirteen-year-olds up there Saturday night and the three of us had a great time canoeing and camping. The stinging nettles were everywhere but we came prepared with a weed whacker and a machete and were able to carve out a nice spot for our campsite.

Tuesday -- June 6, 2006

There is strange white fuzz everywhere. I guess its pollen from the trees and the fuzz from the cottonwoods. Since we haven't had any rain it's had a chance to accumulate on everything. I swept off the canoe shed yesterday; it's really in need of a paint job. I think I'll make a bid to the Club to paint the old metal roofs. I also spent some time clearing spider webs from all the windows.

Wednesday -- June 13, 2006

The young eagles are still hanging around the nest but it won't be long now before they are able to fly and hunt for themselves. The mulberries are just about all gone and happily that means the geese have all gone as well. I've been busy stirring things up in the men's locker room. I moved the door to the bathroom down there and moved a bunch of lockers around too. I organized the life jackets and I even painted! It looks much brighter and roomier in there now. We just saw our resident barred owl. We were waiting for the school bus when it flew up and landed on the big spruce tree in front of the Sycamore store. Today is the last day of school so I should see a bit more activity down here soon.

Friday -- June 16, 2006

The river is low, especially for this time of year. I'm not complaining, a low river means it's easier to pull the ferry; but I am concerned about this drought and what it might mean for my water supply. The weather is beautiful again today and I should get some business. Yesterday, we were honored to have a long-time member, Phil Thorson, down here. He's been a member since 1947!!! It was great to see the two old-timers, John Matthews and Phil, chatting by the canoe shed. I guess if you live in the woods you'll see a tree fall sooner or later, but it was startling to be on the swim dock when a huge limb broke from a tree and loudly crashed into the river. The owls woke me again last night with their eerie hoots and chatterings.

Wednesday -- June 21, 2006

I finally have my phone and Internet working again, a tree fell and snapped my phone line up on the parkway and it took some time for Verizon to get around to fixing it. There is an important event taking place this weekend, The Bioblitz (http://www.pwrc.usgs.gov/blitz/). Over 115 scientists will be in town volunteering their time for the survey, often staying out through the night for their surveys. The event is based out of Glen Echo Park, MD. Educational events will be open to the public through the weekend and a final species count will be announced Sunday, followed up in one year with a publication of findings in the journal Banisteria. Volunteers are needed throughout the weekend for a variety of tasks, including helping with set-up and breakdown of tents, tables and chairs, registration, meal set-up, data recording, and other tasks related to running this large volunteer event. This is a great opportunity to interact with biologists from many places and watch as discoveries are made. Volunteers are needed to help with base camp set-up, registration, meal set up, driving, etc., in two or four hour shifts 10am-10pm Friday, 6am to 10pm Sat and 6am to 6pm Sunday. I decided to help out by offering the Island as a place for the scientist to camp while they're here. I talked with the coordinator and it looks like we will have about twenty scientists here on Friday and Saturday night. They will be hard at work all day and won't show up here until 11:00 p.m. They all leave again by six a.m. so I don't think it will affect most Islanders. I'm glad that we are able to provide this much-needed camping space and do our part for a very worthy cause.

Friday -- June 23, 2006

We see the adult eagles almost everyday and sometimes we see them together by the nest feeding their young. I can't be sure that there are still two baby eagles in the nest. It won't be long now before the young ones leave for good. Air Force One flew by yesterday. It was impressive to see it zoom by below the tree line at a hundred miles an hour with its fighter-jet escort. Our tax dollars at work. I've been enjoying the most idyllic summer days down here this week; this is really the time to be on Sycamore Island. I've had my young nieces and nephews here this week and we have been having so much fun fishing, swimming, watching beautiful sunsets and thunderstorms, and sleeping outdoors.
