#### Minutes: December 13, 2006

The end-of-year December meeting was hosted by Larry and Anne Heilman. It started with a business meeting, and then caretaker Joe Hage joined us for the holiday celebration that followed.

The meeting was called to order at 8:15 p.m.

**Present:** Gerald Barton, Joe Belden, Jim Drew, Renée Dunham, Larry Heilman, Jeff Komarow, John Lentz, Joan MacKinney, Norm Metzger, Star Mitchell, Sherry Pettie, John G. Stapko, John F. Stapko, Christopher Thomson, Peggy Thomson, Bernard Veuthey, Tryon Wells, David Winer, Jane Winer.

Minutes: The November minutes were approved without changes.

**Membership:** Club president Jeff Komarow reported on a request by regular members Bob Henry and his wife Dorothy Barthelmes to take inactive status. Since they are not moving out of the area, which is the reason given in the rules for becoming "inactive", an exemption allowing their request had to be voted on by the membership. Bob and Dorothy will not be using the Club for two years while their son Michael is in the Peace Corps, and they have not been members long enough to qualify for senior status. After a discussion of the issue, a majority vote approved an exemption allowing Bob Henry and Dorothy Barthelmes to take inactive status.

**New members:** Continuing with Membership business, Jeff reported that Allison Levine and Bob Palermo resigned their membership. Jeff then presented two new families for Club membership, one of which has two small children – good news to those members who feel that the Island should be enjoyed by more young children!

A motion carried by unanimous consent to accept new members Jon and Jennifer Glaudemans, and Christie and Garth Ross.

**Election of Officers:** Jeff called for nominations or volunteers from the floor to serve as a Club officer or committee supervisor, but none responded. He then presented the slate of officers listed in the November *Islander*, who were immediately accepted by unanimous consent.

**2007 Budget:** A motion carried to accept the proposed budget printed in the December *Islander* as the Club's spending guidelines for 2007.

**2007 Dues and Fee:** A motion carried to levy an across-the-board five percent increase in all Club dues and fees.

**Upcoming meeting sites:** Jeff reminded us that the Club has a new tradition of holding the February meeting at Frank Daspit's pub downtown. Several possibilities for January meeting sites were raised, but none definitively. [Since then, Whitney Pinger and Roger Pollack have volunteered to host the January meeting. Details in President's letter and last page.]

The meeting adjourned at 9:40 p.m., and those present moved to our hosts' dining room and kitchen for holiday refreshment and conversation.

From the Archives Almost 122 Years Ago

In a document titled, "Sycamore Island Pleasure Club, Organized Apr. 3, 1885" we find the first set of Rules. There are 14 in all—and some may appear familiar.

1. This Club shall be known as the "Sycamore Island Pleasure Club."

2. That the membership of this Club shall not consist of more than 15 members. [The numeral is crossed out, and 35 is written above.]

3. The officers shall consist of President, Treasurer, and Secretary. The President to preside at all meetings, and in his absence the Secretary.

4. The Club shall meet for the transaction of business the first Monday [crossed out and replaced with Thursday] of each month. The place and hour of the meeting to be determined at the previous meeting by the President or such officer as may be in charge.

5. The Secretary shall keep an accurate record of all of the proceedings of the Club.

6. The Treasurer shall dispose of the funds in such manner as the Club may direct and be ready at any time to exhibit the sources and amount of receipts and amount of disbursements.

7. The regular contributions of members shall be 25 [crossed out and replaced with 50] cents a month, payable monthly.

8. Any member failing to pay dues or assessments within sixty days [crossed out and replaced with twelve months] shall not be entitled to vote and shall, in addition, be disqualified from receiving any benefits.

9. Any member wishing to dispose of his share of stock, shall give at least one month's notice, and the Club to purchase at a valuation to be determined on by the President and two (2) members; the member selling to have the privilege of appointing one (1).

10. Any member wishing to use the boats must give at least 24 hours notice.

11. That a committee of 3 members shall have the power of determining whether any member shall use the boats, provided said member's application is made for the use of the boats on any day except Sunday or legal holidays, and said applicant shall be responsible for the boats while in his possession. The committee to keep the boat in repairs, the cost of repairs to be paid by the Club.

12. That on the first Sunday of each month the boats shall be at the disposal of the members of the Club and their friends, the remaining Sundays for members only.

13. That a quorum of members of this Club shall not consist of less than 6 members.

14. That in case of a vacancy occurring in the membership of the Club it may be filled by the unanimous vote of the members present.

#### In Touch With Joe....

Happy New Year to everyone. We Island dwellers hope you all had a wonderful holiday. We've had a very nice month down here. The weather has been amazing and every time I think it's going to be the last nice day before winter, we get another warm, sunny day. The Island has been busy with my regular visitors and we did have a couple of holiday gatherings down here as well. It's been fun decorating the clubhouse and the ferry with wreaths and lights, having aromatic fires in the wood stove and singing carols around the pool table. We decided not to bring a Christmas tree down here this year and instead we decorated our ficus tree and put that in the window. Looks pretty good.

I fixed the baseboard heaters in my bathroom. They haven't been working since the first of the cold weather hit and we've been getting by with just a space heater in there. I wasn't confident that I could fix the problem and I was on the verge of calling in an electrician. I had to do something because I knew that the space heater would not be sufficient to keep the pipes from freezing in this under-insulated room. I shut off the power, took apart the switch, and found the problem: A disconnected wire. With a little trouble I was able to reconnect the wire and restore the heat to the bathroom.

I've seen a few wintering birds like the red-necked grebes and the common mergansers. The redshouldered hawk is always around and I saw a merlin at the top of a dead sycamore. The eagles have been spotted near their nest and I caught another glimpse of our nocturnal friend, the flying squirrel. Birds that are strangely absent are the seagulls that are usually massed out in the middle of the river at this time of year; but not so this year. Maybe it's the warm weather that has them on a different schedule. Speaking of the warm weather, I'm afraid that the bluebells might start emerging here soon. We already have a number of green shoots coming up and the silver maples are starting to bud as well. Can you say climate change?

Tryon and I noticed as we were driving on the towpath to deliver a huge roll of roofing rubber down to the Island that the Lock Six house is now vacant. I guess that young couple and their baby moved out and I've lost my closest neighbor on the canal.

This obituary was sent to me by Claire Collins Conner, the widow of Donald Conner. She said that she met her husband on Sycamore Island where her father was a member back in the late twenties and early thirties.

Donald Lawrence Conner, 99, of Midland, Michigan, died at his residence on Friday Dec. 15, 2006. Born in Washington D.C., he was the son of William Wallace Conner and Marie Louise Stephenson Conner. He married Claire Hayden Collins on November 24, 1934, in Washington DC. He was truly a renaissance man. In his youth he excelled at sports. He was a national East Coast champion canoe racer, ran track where his events were the hurdles and high jump, and played semi-pro baseball. He was proud of canoeing the entire length of the Potomac River. He belonged to the Sycamore Island Club.


