Minutes for the December 12th Meeting

The meeting was called to order by President Jim Drew at the home of Karen Possner and Stan Wiggins, who welcomed us into their home for a festive holiday party following the meeting.

Minutes: The minutes as they appeared in *The Islander* were approved.

Treasurer's Report: Caroline Gelb reported on the 2012 budget and expenditures in Alan's absence. The total expenditures as of the end of October were close to what was expected. Unexpected expenses of repairs to a leaky roof and a new water pump were somewhat offset by savings on distribution of *The Islander*, grounds, and careful spending on entertainment and supplies. Salary and insurance remain the biggest expenses. With the expected expenses for the rest of the year, including the caretaker's bonus plus a special 10-year service award, the total spending for the year is likely to exceed the budget by about \$4,000. However, our income was higher this year primarily due to the entry fees of the new waiting list applicants. This will result in a reserve of about \$75,000, an increase of about \$5,000.

For the 2013 budget, the Gelbs are proposing an increase of 2.1%, to a total of \$83,828 in the operating budget. Adding in the funds necessary to service the notes on the building loans, the total budget will be \$93,111. No change in dues or fees was proposed. A motion to adopt the budget was passed.

Membership Report: John Noble reported that there will be two new families proposed for membership next month. The roster of members that usually is distributed with the January *Islander* will instead be sent out in April after the dues payments are made so that it will be more accurate.

Relief Caretaking: Sherry Fizdale presented a list of all members who served as relief caretaker during the year

(shown in this issue). She recommends that they be reported each month in the future, so that there will be an official record of members who serve.

Captain: Drew Walsh reported that the steps to the shed have been finished. Dave Winer is building a workshelf on wheels. The bathroom is being winterized. And the Environmental committee is strategizing.

Sycamore Island 2012 Budget: Summary Report

Our operating budget for 2012 was \$82,104. Our spending ended up close to this at \$82,682, which represents an overrun of 0.7%. This was mainly due to a number of large expenditures, including fixing the roof, a new water pump, fire extinguishers, and safety equipment, substantially more than we budgeted. Insurance costs were also slightly higher than projected. We saved on *The Islander* and on routine spending for maintenance and Island supplies.

Because of the exceptionally high level of income in 2012, we ended the year with a balance of \$78,182 in the Treasurer's account. This is the highest carryover we have had since at least the late 1990s, excepting the unusual level in 2008 to fund new construction, but it is still below our goal of one year's operational spending. We do of course still owe the balance of our construction notes. Originally \$65,000, this has come down to \$49,875.

WINTER BIRD WALK

Please join us for the Fourth Annual Sycamore Island Winter Bird Outing scheduled for Saturday, February 9th, 2013. As in past years, we will begin the outing at 8:00 AM with bagels and coffee at the clubhouse. Our plan is to walk the Island and the towpath in the vicinity of the Island from 8:30–10:30 a.m. looking for visiting winter waterfowl and other winter resident and migratory birds. Following the walk, we will compare notes on the day's sightings over coffee around the wood stove in the clubhouse. Both beginners and experienced birders are encouraged to join us.

Last year, participants walked the Island and were rewarded with good looks at numerous resident and migratory birds, including: Wood Duck, Ring-neck Duck, Bufflehead, Hooded Merganser, Common Merganser, grebes and various woodpeckers. Our resident Bald Eagles usually start to nest this time of year just down river from the Island in a Sycamore tree that is also easily seen from the Island. 

From MacArthur Boulevard in either direction: coming from DC turn right on Mohican Road; from Glen Echo turn left on Mohican Road, proceed up hill, bear right at stop sign, then left. 5424 is on left.
