They had a mud fight and covered each other with black stuff. After washing it off, grandson Bryce grinned and said, "let's do it again!" and they did! What memories!

They say that it is supposed to get a lot colder tomorrow so I'm getting everything on the Island ready for the cold snap. I installed the temporary insulating walls in the men's bathroom. I turned off the water to the Club house and to the ladies bathroom. I drained all

there.

By 2:00 the ice had melted enough and I was able to pull the ferry across no problem.



Proposed Changes to Camping Rules

At the November meeting, the proposed changes to the camping rules generated discussion that was postponed until January. The changes were proposed in order to define a balance between a caretaker's right to privacy during off-hours and the members' right to use the Island by clarifying the existing rules so that members will understand when their requests will be granted, and which Large Party rules are applicable.

The existing rules are:

4. Camping Rules

The following rules shall be observed regarding camping on the Islands:

- a. Overnight camping shall be coordinated in advance with the supervisor of camping (or in his absence, another officer) and the caretaker.
- b. Large Parties that involve overnight camping are subject to the provisions in Standing Rule 3, Large Parties and Guests.

The proposed text is:

4. Camping Rules

The following rules shall be observed regarding camping on the Islands:

- a. Overnight camping shall be coordinated in advance with the Supervisor of Camping **and Parties** (or in his absence, another officer) and the caretaker.
- b. The caretaker will approve requests for overnight camping, provided:
 - 1. The request is made at least three days in advance,
 - 2. There is no other event scheduled for that evening,
 - 3. The host will operate the ferry,
 - 4. The host understands that the caretaker is unavailable except in case of an emergency.
- c. Large parties that involved overnight camping are subject to the provisions of standing rule 2, paragraph b (quiet hours) and d (stowing camping gear), and standing rule 3, paragraphs c (odd-numbered days and approval of supervisor), f (vacate by 11:00), h (indemnification form) and i (sanctions for non-compliance.)

Dave Winer proposed this alternate text:

4. Camping Rules

Members may camp on the Island at any time, subject to the following provisions:


- a. After normal hours of the caretaker's duty:
 - 1. The caretaker shall not be involved. Campers shall not act in any way that disturbs the caretaker's private hours or quarters.
 - 2. Camping members and their guests must operate the ferry independently of the caretaker.
- b. Camping members with number of guests meeting large party limits shall conform to all requirements for holding large parties.

Here are comments from previous Supervisors of Camping and Large Parties:

- 1. Would be good if there were a service component to camping—say, one day as substitute caretaker within past year to camp. Pretty minimal, since helping out is a member expectation.
- 2. Perhaps camping when the caretaker is not there (i.e., Saturday night) could be earned by having been substitute caretaker 3 times within the past year -- surely by stint 3, the person has learned enough to take care of most emergencies.

- 4. I do think people should be required to give at least a weeks notice if they want to camp. Too often people call me at the last minute.
- 5. On the parties, if we want to generate more revenue I would change the rule to permit people to have parties as long as they have completed two services for the club as opposed to the current three.

A concern that was expressed during the discussion at the November meeting is that if the campers are using the ferry to come and go from the Island, it must always be left where it is available for the caretaker to use.

The discussion will be continued at the January 11 meeting, and a decision will be reached.



Beneath the Surface

Betty Burchell, who was a member of the Sycamore Island Club from 1957 until her death in 2003, convinced American University to do an archeology study of Ruppert's Island. The study showed that American Indians had lived there at various times over thousands of years, much longer than anyone had imagined. Here's the story she wrote in 1985 for the centennial edition of the Sycamore Islander.

It was all John Thomson's fault. He asked me to ask my husband, Bob, in preparation for an encampment of Boy Scouts, to spray the area around the mounds on Ruppert Island for poison ivy. Nobody had ever called them mounds to my knowledge. It turned out they were not man-made mounds, but they looked pretty unusual to me and when the right time came along they started my imagination to work. This was 1964.

My family can take some credit too. One summer afternoon Bob was fishing in a rowboat near Ruppert, Kenny and I had dropped off on the shore nearby and proceeded to explore the center of the unspoiled isle. We sat down near the mounds, which were long, low humps. Arrowheads had often been found on Ruppert, so I felt fairly confident in telling Kenny that Indians once lived here. He was five years old at the time. It was mostly a question of amusing him. But there were the humps! In went my fingers, hand, and arm through the loose river sand.

Ooops! I felt sharp edges and started hauling out little pieces of thin rock, most unlike the water-worn stuff usually found in river beds.

In the weeks that followed I interested my friend Joan Thal-Larsen, who had two little boys. We took our little ones on many occasions, found more sharp rocks and even bits of crude pottery. It was most exciting and time-consuming. We brought the stuff home to save it.

But I realized this would never do. If it were important we were destroying it. We didn't know anything about archaelogy. So one day we took our artifacts and our children to the Smithsonian. It wasn't all that easy to get an interview. Dr. Carl Miller helped us with advice. We got started measuring and recording. Due to illness he could not come to the site until much later. But through him we enlisted members of the Maryland Archaeological Society. They came, worked, and taught us quite a bit. They got us a site number, 18 MO 26.

Minutes for December 14, 2016 Meeting

The members gathered at the home of Meredith Griggs for the Annual meeting/holiday party. Tryon Wells then called the meeting to order. The first order of business was to thank our hostess for sharing her home with us on this festive occasion.

Membership Report: John Noble provided a summary of membership activity for the year. The Club currently has the maximum of 160 regular members with 13 of them becoming members in 2016. There are also 71 senior members, 6 of whom became eligible this year after 20 years of regular membership; 22 inactive members who are living outside the area; and 15 honorary members. There are 59 Waiting List Applications (maximum 60).

Nominating Committee: John Noble and Bill Marmon assembled an august team of volunteers who will serve as officers and supervisors in 2017. But first, John recognized those who have served us well and are now retiring from their current positions, particularly those who have served for many years, Financial Secretary Lisa Kliefoth (~20 years), Editor Carol Beehler (6 years), Captain Drew Walsh (4 years), Law Supervisor Parker Moore, our President Tryon Wells, Supervisor of Large Parties Jonathan Zimmerman, and Supervisor of Swimming Roger Herst.

Then John introduced those officers who are leaving the current position to take on new responsibilities - Richard Bertaut takes up the gavel as he moves from Vice President to President, John Noble will cease conducting new member orientations and takes on the Vice Presidency, Sharon (Sherry) Fizdale leaves her position as Supervisor of Finance and becomes Financial Secretary, and Ann Marie Cunningham sets down her notepad and becomes Supervisor of Finance.

Officers who are remaining in their current roles include Ned Goddard as Treasurer, Lucky Marmon as Co-Recording Secretary, Karen Possner as Archivist, Rodolfo Castro as Deputy Captain, Marianne Ross as Supervisor of the Clubhouse, Alice Bullard as Supervisor of Grounds, Karl Kosok as Supervisor of Painting/Carpentry, Tryon Wells as Supervisor of the Website, George and Shelley Malusky as Supervisor of Entertainment, Joe Cecil as Supervisor of Canoeing, and Madeleine Carter as Supervisor of Relief Caretaking Scheduling.

Those who are new to Island leadership were warmly welcomed - Stan Fowler as Captain, Rebecca Beynon as Supervisor of Law, Molly Newberry as

Supervisor of Camping and Large Parties, Larry Heilman as Supervisor of Swimming.

All the nominees were elected by acclamation.

John also reported that there are still a few opportunities available to those who wish to become more involved with the Island. Please contact John if you are interested in becoming the Membership Secretary, Editor, or Co-Recording Secretary.

Treasurer's Report: Ned Goddard reported that the Club has been spending more each year, primarily because of rising insurance costs and unexpected repairs. There will be an increase in dues and fees of approximately 5% in 2017. The number of members is specified in the Bylaws. Contact Ned if you are interested in details on expenditures and income. The budget passed.

Relief Caretaker Scheduler's Report: Madeleine Carter reported via email that she is very grateful to those members and wait list applicants who operated the ferry for us in November. Greg Hitz, Meghan Mullan (TWICE!), John Beck, Sherry Fizdale, Edward Tilghman, Eric Simpson, and Renee Dunham enjoyed a lovely day on the Island with occasional ferrying responsibilities.

Next Meeting and Adjournment: The next meeting will be held on January 11 at 8:00 at the home of Susanna and John Membrino, 5305 Tuscarawas Road, Bethesda. The meeting was adjourned so we could enjoy a delicious repast and the lovely home of Meredith Griggs.
